- Arrive camera-ready (minimal “getting ready” space provided)
- Maximum of 10 total guests (including Couple). Additional guests +\$75 per person (max 20 total).
- No rice, confetti, fake petals, balloons, sky lanterns, or open flames (sparklers allowed only with prior approval and fire extinguisher present).
- Alcohol beyond the provided bottle must be pre-approved; no hard liquor permitted.

8. Venue Policies

- The Venue is a working orchard; light farm activity or guests may be visible in the distance.
- No pets except pre-approved service animals.
- Couple grants Venue unlimited use of photos for marketing (faces may be obscured upon request).

9. Force Majeure

If the event cannot take place due to acts of God, government restrictions, or other circumstances beyond control, the Couple may reschedule to any available date within 18 months at no additional fee.
